### **Queen's Contest**

### Superintendent(s): Rhonda Payne & Christy Cornelius

2024 will be the 36th year for the Robertson County Fair Association (RCFA) Queen's Contest. Queen contestants are residents of Robertson County and sponsored by local organizations. The sponsors and contestants sell raffle tickets, the proceeds from which cover scholarships and incurred expenses of the RCFA. Each contestant meeting the raffle ticket sales quota will be judged in five categories: personality, poise, appearance, fair participation, and general knowledge of the RCFA. The contestant selected as Queen will reign over the Fair.

The Queen's Committee and the RCFA give a special "Thank you" to each of these lovely young ladies. Our congratulations and best wishes are extended to all contestants.

### **Queen's Rules**

- 1. The Robertson County Fair Association (RCFA), Inc. reserves for its Officers and Board of Directors the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of, connected with or incidental to the Fair. The Management reserves the right to modify, change or add to these rules as it, in its judgment, may deem advisable. Any person who violates any of the general rules or specific rules will forfeit all privileges and premiums won. The RCFA, Inc. will not be held legally responsible for any damages or injuries to any persons, personal properties, exhibitors, exhibits or livestock while on the grounds or in transit thereto or therefrom or any cause whatsoever!
- 2. Contestant must be a single high school girl living in Robertson County or enrolled in a Robertson County high school, sponsored by a local organization, and academically eligible (passing) for the entirety of the Robertson County Fair (Queen's Coronation thru the Premium Sale). If a contestant marries and/or becomes pregnant before the coronation, she must relinquish her position to participate in the contest.
- 3. Each sponsoring non-profit organization may have a substitute contestant. Should the need arise for a substitute; they must also meet the rules, requirements, and responsibilities as outlined in these rules. Due to advertising constraints, deadline for substitutes to be able to participate is Monday, February 5, 2024. If a substitute is needed and there is not one available, the organization will not be represented. Failure to complete all duties required by a candidate, unless approved by the committee or board, could lead to ineligibility of any future queen contest.
- 4. Any girl, other than a previous Fair Queen, is eligible to participate as a candidate provided, she meets the other qualifications.
- 5. Each contestant must participate in the Robertson County Fair by having an entry in at least one division of the fair (Livestock, Creative Arts, Food Division or Shop Division). All entry fees and /or late fees must be paid by the deadline set forth by the RCFA or the contestant will be disqualified from the Queen's contest.
- 6. Each contestant must be an active member of FFA, FCCLA, or 4-H prior to January 1, 2024.

- 7. Contestants must sell a minimum of \$600 of raffle tickets prior to participating in the Queen's contest. If for any reason a contestant drops out or is excused from the contest, the contestant/sponsor will be responsible for the \$600 in raffle ticket sales. Each candidate will only be allowed to check-out a max of \$200 in additiona7l tickets at a time. You and/or your club sponsor will be responsible for all tickets distributed out. All tickets will be reconciled by the morning of your scheduled interview to be eligible.
- 8. Each contestant will be responsible for turning in the designated amount of sold tickets and money on the dates designated in Queen Candidate packets. Each contestant is responsible for being at each of the ticket turn-in meetings. Additional tickets can be obtained from any committee member. Any unsold tickets must be turned in at the final ticket turn-in. Each contestant who reaches a goal of \$1,000 in raffle ticket sales will receive a \$50 gift certificate. Each contestant who reaches a goal of \$1,500 in raffle ticket sales will receive a \$100 gift certificate. Each contestant who reaches a goal of \$2,000 in raffle ticket sales will receive a \$200 gift certificate.
- 9. All contestants must attend a "meet & greet" event on the day of the pageant. Interviews will be done immediately following. Contestants will be judged in appearance, poise, personality, and general knowledge and involvement in the Robertson County Fair.
- 10. The points you receive for fair participation are based only on the number of years of participation in the Robertson County Fair. Eligibility begins with the third grade.
- 11. Each applicant's official entry form must be received by the Superintendents of the Queen Committee (not mailed) no later than 5:00 pm on Monday, November 20, 2023. Applications must be complete. No late applications will be accepted. All rules will apply as of entry due date.
- 12. The Fair Queen and the 1st and 2nd runner-up will each receive a token of appreciation.
- 13. If the Queen marries and/or becomes pregnant during the time of her reign, she must relinquish her title and all that it encompasses. The first runner-up will then become eligible, and if for some reason the first runner-up declines, with committee approval, then the second runner-up will become eligible.
- 14. All decisions by the Queen contest judges and the Queen's committee are final.

The 36<sup>th</sup> Annual Queen's Coronation will be held on Saturday, March 9, 2024, at 6:00 p.m. inside the Fireman's Hall located at the Robertson County Fairgrounds in Hearne, Texas.

### **Little Miss Contest**

2024 will be the 3<sup>rd</sup> year for the Robertson County Fair Association (RCFA) Little Miss Contest. The contestant's parent(s) or guardian(s) agree with the RCFA that this contest is for the sole purpose of extending opportunities to the children of this county to participate in a fun event while having a good experience.

The Little Miss Committee and the RCFA give a special "Thank you" to each of these lovely young ladies. Our congratulations and best wishes are extended to all contestants.

#### Little Miss Rules

- 1. The Robertson County Fair Association (RCFA), Inc. reserves for its Officers and Board of Directors the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of, connected with or incidental to the Fair. The Management reserves the right to modify, change or add to these rules as it, in its judgment, may deem advisable. Any person who violates any of the general rules or specific rules will forfeit all privileges and premiums won. The RCFA, Inc. will not be held legally responsible for any damages or injuries to any persons, personal properties, exhibitors, exhibits or livestock while on the grounds or at any fair related function.
- 2. Contestants must be between the age 5 years and 7 years old as of September 1, 2023, and must be a resident of Robertson County or a peewee member of any Robertson County 4-H club. A photocopy of the contestant's birth certificate must be submitted with entry form for age verification and will be returned to parent/guardian. Failure to submit the birth certificate with the form will disqualify the contestant.
- 3. Contestants must attach a recent snapshot with the application. The snapshot must be of the head and shoulders only, no glamor shots will be accepted. Contestants will be required to pay a \$25 entry fee. Any previous Little Miss is ineligible to compete.
- 4. Contestants should wear western attire, at their choice, for the final judging of contest. Hats are optional. The judging will be Thursday, March 7th, 6:00 pm at the Fireman's Hall. All contestants must attend. Winners will be announced at this time.
- 5. Each contestant must participate in the Robertson County Fair by having an entry in at least one division of the fair (Pet Show, Mutton Bustin', or Kids Playtime).
- 6. The girl selected as Little Miss must appear on behalf of the Robertson County Fair Association when asked. If for some reason the child is unable to fulfill her responsibility, the first runner up will assume the title.
- 7. Each contestant must sell a minimum of \$50 of raffle tickets to participate in the Little Miss contest. Money raised will be used for the Little Miss event, sashes, awards, gifts etc. Top Ticket Sales award will be given to the winner that sells the most tickets.
- 8. Each contestant will be responsible for turning in sold tickets and money by Sunday, February 4, 2024.

- 9. Entry forms must be provided to any interested party that meets all above requirements. Entry forms must be received no later than 5:00 pm on October 20, 2023. Entry forms may be returned to the Extension office in Franklin or by mail to 2092 Vaughn Ln. Hearne, TX 77859.
- 10. Judges will be selected from outside Robertson County, if at all possible.
- 11. Contestants parent(s) or guardian(s) agree that the time, manner, and method of judging shall be solely within the discretion of the Robertson County Fair Association and that the decision of the judges shall be final.
- 12. Contestants will be judged as follows: 50% Personality, 30% Poise, 20% Attire
  - a. Little Miss and Top 4 will each receive a token of appreciation.
- 13. Other awards will be given to the following:
  - a. Best Dressed
  - b. Miss Photogenic (4x6 photo entered by contestant / judged by a panel)
  - c. Miss Sunshine
  - d. Miss Future Farmer
  - e. Miss Bright Smile
  - f. Top Ticket Sales (contestant who sold the highest number of raffle tickets)
- 14. All contestants must attend the Queen's Coronation, Saturday, March 9, 2024, at 6:00 pm. All contestant's will be introduced and the Top 5 will help award the winners of the Queen's contest. 2024 Little Miss will help crown the 2024 RCFA Queen. Western Dress Attire.
- 15. Little Miss is encouraged to attend as many fair shows as possible to hand out ribbons.
- 16. All participants must comply with the Robertson County Fair Association General Rules and Regulations printed in this packet, unless otherwise specified. Entries to exceed 25 applicants will be selected from a random drawing.

The 3<sup>rd</sup> Annual Little Miss contest will be held on Thursday, March 7, 2024, at 6:00 p.m. inside the Fireman's Hall located at the Robertson County Fairgrounds in Hearne, Texas.

### **General Rules**

- 1. The Robertson County Fair Association (RCFA), Inc. reserves for its Officers and Board of Directors the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of, connected with or incidental to the Fair. The Management reserves the right to modify, change or add to these rules as it, in its judgment, may deem advisable. Any person who violates any of the general rules or specific rules will forfeit all privileges and premiums won. The RCFA, Inc. will not be held legally responsible for any damages or injuries to any persons, personal properties, exhibitors, exhibits or livestock while on the grounds or in transit thereto or therefrom or any cause whatsoever!
- 2. All show exhibitors, except for adults in the creative/visual arts divisions, must be academically eligible to participate in the Robertson County Fair. Each Independent School District (ISD) must provide written documentation of eligibility and it must be signed by an authorized school official. Exhibitor's designation of an ISD or Homeschool at time of entry is final.
- 3. All entrants in the Youth Division of the Robertson County Fair (RCF) must be a member of a Robertson County FFA Chapter or Robertson County 4-H Club (Robertson County FCCLA Chapter Homemaking Division Only). These youth must be in good standing in their chapter or club, 4-H and FFA members must have attended at least one meeting between September 1, 2023 and January 1, 2024. Eligible youth may participate in only the Robertson County Market Division and not another county's market show. Such participation in the same school year will render the market exhibitor ineligible for the RCF market show. Additionally, all youth exhibitors must satisfy one of the two following requirements: (a) Must be a resident of Robertson County or (b) must attend a public, private or home school in Robertson County. All entrants must satisfy one of the two requirements for the duration of the project (from the project validation date until the sale date of the animal). All entrants in the market division must also complete a RCFA eligibility form for each species validated for show at the RCF.
- 4. All exhibitors are responsible for getting entry forms filled out online. These forms must be turned in by March 1, 2024. Anyone needing additional help should contact their County Extension Agent or Agricultural Science Instructor. All entries in the market steer, market lamb, market goat, and market hog divisions will be charged a fee of \$25.00 per head.
- 5. Entries received March 2, 2024 through March 8, 2024 will be assessed an additional late fee that equals double the entry fee per entry (Late Fees: Creative Arts \$10, Breeding Animals \$40, Market Animals \$50). Entries received after March 8, 2024 will only be accepted until the end of the project check in with a \$250 late fee. Entry fees will NOT be refunded.
- 6. Animals not tagged in for major shows must adhere to the following:
  - a. Market steers will be nose printed, ear tagged, and charged a \$5.00 per head tagging fee.
  - b. Market lambs will be nose printed, ear tagged, and charged a \$20.00 per head tagging fee. Must have a scrapies tag in place at time of check in.
  - c. Market goats will be tattooed, ear tagged, and charged a \$20.00 per head tagging fee. Must have a scrapies tag in place at time of check in.
  - d. Market hogs will be ear tagged and charged a \$5.00 per head tagging fee.
  - e. Commercial heifers will be tattooed with a RCFA tattoo, ear tagged, and charged a \$10.00 per head tagging fee.
  - f. Market rabbits will be tattooed and charged a \$10.00 per family tattooing fee.
  - g. Market poultry will be wing banded. Any fees will be added to the cost of poultry and paid at the time the birds are picked up.

If an animal loses a tag, the superintendent must be notified within seven days and a replacement tag requested. All replacement tags must be in place before fair check in of the division.

- 7. A corresponding list based on entries will be given to each division superintendent at the time of the show. Anyone not found on this final list will not be eligible to show. Divisions included in this rule are: market steers, commercial heifers, market lambs, market goats, market hogs, market poultry, market rabbits, visual arts and food.
- 8. All exhibitors in the market division must provide the primary care of all animals entered in their name from time of tag-in to after the sale date of the animal.
- 9. Exhibitors may show in more than one market division but are limited to one entry per division and may only sell one entry through the fair auction, whether Silent Auction or Premium Sale, with the exception of the Commercial Replacement Heifer Sale.
- 10. Market animals may be validated in the immediate family name or individual name. The immediate family is defined as a whole blood, half blood, step brothers and sisters, and legally adopted. A decree of adoption, birth certificate, and certificate of marriage may be required for verification. Failure to supply these documents may result in disqualification. All exhibitors must complete the exhibitor eligibility form for each market division entered as outlined in General Rule #3.
- 11. Quality Counts training must be completed by all exhibitors entering animals in any division (market, breeding and/or commercial) prior to entering the RCFA show and proof of completion of the Quality Counts training (individual completion number under the new age divisions set in 2019) must be included with the division entries.
- 12. The Grand Champions and Reserve Champions in each division except Homemaking must sell. The sale will be limited as explained in each division. If an exhibitor has the Grand Champion in one division and the Reserve Champion in another division, then he or she must sell the Grand Champion animal. If an exhibitor has two Grand Champions or two Reserve Champions, then the exhibitor must pick which animal to sell. Ribbons will be awarded in all divisions and belt buckles will be awarded to Grand Champion and Reserve Champion market show.
- 13. Exhibitors must declare their species/item for the sale no later than 30 minutes following the completion of the market swine show on Sunday. This is defined as the Declaration Time. If after the declaration time the exhibitor has not made a decision, the declaration will be made by the RCFA.
- 14. Any animal that dies or is deemed not sellable (broken bone or visibly sick) prior to the declaration time will be pulled from the sale and the next alternate will move up. After the declaration time any animal that dies or is deemed not sellable (broken bone or visibly sick) will be pulled from the sale and the sale hole will not be filled. Upon the death of an animal, a post-mortem inspection of the carcass is required. If the death or injury of the animal is found to be from unethical treatment of the animal and not in accordance with the rules of the RCFA the exhibitor will be subject to Rules #28 through #33 of the General Rules. Cost of the post-mortem inspection will be covered by the fair if the animal is found to have died from natural causes (ex. heart attack not caused by drugs, broken neck). Natural Cause will be determined by the fair board under the direction of the attending neurologist. If the animal is found to have died due to unethical fitting or treatment of the animal the cost of the post-mortem inspection will be paid back to the Robertson County Fair Association by the exhibitor. In the instance that the cost of the necropsy of the deceased animal is not repaid to the RCFA by September 1 of that show year the exhibitor and any siblings will not be allowed to validate an animal or enter an animal in the fair for the remainder of their eligible years.
- 15. All market animals will remain within the fenced area of the fairgrounds from the time of check in until released by the division superintendent. Only animals entered and checked into the show are allowed on the fairgrounds. No buddy animals.

- 16. Market animals must be shown and sold by the 4-H or FFA member who entered the show animal. The only exceptions are: (a) the exhibitor is ill or a death in the immediate family has occurred, (b) the exhibitor has another animal being shown in another division at the same time, or (c) the exhibitor is participating in another approved, school, 4-H or FFA event. The appropriate division superintendent must approve the use of a substitute showman prior to the show or sale.
- 17. All entries must be owned by the 4-H or FFA exhibitor according to the length of time determined by the RCFA and the division rules. Once entries are validated the exhibitor is open to spot checks to confirm the projects are in the exhibitor's possession and under their care at all times. Any exhibitor found to not have possession of the project will be subject to disciplinary action from the board, up to and including banning from the show. Negative findings will be reported to the appropriate validation authority.
- 18. All checks for livestock listed in the sale order will be payable to the RCFA, Inc. and a commission will be taken by RCFA for payment of ribbons, trophies, facilities, and improvements.
- 19. RCFA will not allow any material to be used that will alter, change, add and/or remove color. RCFA will not allow any material to be used that will alter the appearance of an animal. "Any material" can include, but is not limited to, paint, powder, dye, oil, glue, hair spray, etc. Any animal found to be altered in any manner may be disqualified from the show and/or sale. No painting or decorating animals for the sale.
- 20. Entries in the breeding divisions must be members of a 4-H or FFA club and attending a public, private, or home-based elementary, junior high or high school. Exception is any Pee Wee classes.
- 21. All breeding show exhibitors are NOT allowed to use a substitute showman in cases of ineligibility due to failing grades.
- 22. RCFA will give showmanship awards in the steer, lamb, goat, hog, poultry, and rabbit divisions. All exhibitors participating in showmanship will be required to show the animal entered and exhibited under their name, in their respective divisions (no exceptions). Showmanship classes for poultry and market rabbits will be broken down as follows: Juniors (grades 3-8) and Seniors (grades 9-12). The showmanship classes for steers, sheep, swine, and goats will be: Junior (grades 3-5), Intermediate (grades 6-8), and Senior (grades 9-12).
- 23. Any animal not meeting the stated criteria for that species show and/or found to be unhealthy (such as, but not limited to; diseased, broken bones, deceased, sick, open contagious wounds, etc.) will be disqualified from all parts of the livestock show from the point discovered forward. After completion of the sift, poultry will be exempt from the broken bone and death clause. All other Texas Animal Health Commission rules will be followed in each division of livestock and poultry.
- 24. Each livestock committee will hold one or more mandatory project clinics. Dates, times, and number of clinics will be determined by each committee. Participation in clinics will be required for all exhibitors showing market animals and/or Commercial Heifers entering their first year of showing within a particular species at the Robertson County Fair. All other exhibitors are encouraged but not required to attend these clinics. Participation in the Holiday Classic and/or the Southern Classic and/or East Texas Star Show clinics will count toward meeting the clinic participation requirement. Each committee will hold a makeup clinic. Participation in other events to meet the clinic requirement may be determined by the committee.

- 25. All Exhibitors with sale items are expected to be at the fairgrounds in the main arena stands on Monday, March 25, 2024, no later than 8:30 a.m. and assist with set-up and clean-up for the auction. Those unable to attend on Monday will be given an alternate day that week. All schools will be contacted on Monday to verify attendance in school. Students not at the fairgrounds all day on Monday will not receive an excuse for school absence from the county Extension Agent, Agricultural Science instructor, or Home Economics teacher. Any exhibitor that makes the silent auction or premium sale that does not attend Monday's set-up and clean-up day will have their auction check held until the exhibitor makes up for the missed set-up/clean-up day.
- 26. Exhibitors are required to prepare thank you notes and bring to the RCFA Annual Meeting. Envelopes for the thank you notes must be un-sealed, addressed to their respective buyer and have postage already affixed. All sales checks and pictures from the fair will be held until thank you notes have been received by RCFA. If appropriate funds have been collected to clear sales checks, exhibitor checks and pictures will be distributed at the RCFA annual meeting to be held at Fireman's Hall on Sunday, April 28, 2024 at 1:30 pm. Those exhibitors receiving buyer's pictures at the annual meeting are required to deliver these pictures to the appropriate buyer.
- 27. RCFA livestock show will have a terminal Market sale (excluding rabbits and poultry). All market animal projects (steers, pigs, lambs, goats) sold through the sale will become the property of the floor buyer after selling. NO ANIMAL BUYBACKS WILL BE ALLOWED ON THE GROUNDS. No exhibitor and/or representative may contact a buyer at any time concerning the project. Any person violating this rule will be subject to disciplinary action as decided by the board. Exhibitors who choose to sell non-sale animals on the floor truck will be accessed a \$5.00 processing fee by RCFA. The RCFA reserves the right to reweigh any floor animal.
- 28. Exhibitor and exhibitor's parent(s)/guardian(s) certify that the entry has not been administered or that the exhibitor and exhibitor's parent(s)/guardian(s) do not have any knowledge that this entry has received any substance not approved by the Food and Drug Administration (FDA) and/or the United States Department of Agriculture (USDA) for food animals. Furthermore, the exhibitor and exhibitor's parent(s)/guardian(s) certify that the entry is free and clear of ALL drug and chemical residue withdrawal and elimination time periods.
- 29. All livestock are subject to drug testing. At a minimum, the Grand Champion, Reserve Champion and one random of each market livestock division will be tested for drug residue. During the collection of samples, the Exhibitor or designated responsible adult must be present at all times unless a substitute Exhibitor is approved by the superintendent. Exhibitors found in violation of this rule are subject to disqualification.
- 30. The use by non-veterinarians of animal drugs or other substances in any manner other than in accordance with the labeling approved by FDA is a violation of federal law. Exhibitor and exhibitor's parent(s)/guardian(s) agree that:
  - a. they are absolutely and completely responsible persons for the care and custody of their animals,
  - b. the Robertson County Fair Association shall be entitled to disqualify, and all money and prizes will be forfeited from, an exhibitor whose animal tests positive for any drug, even if the exhibitor and exhibitor's parent(s)/guardian(s) are innocent of any wrongdoing and did not administer the drug,
  - c. the residue test results of the testing laboratories are final and binding upon the exhibitor and the exhibitor's parent(s)/guardian(s).

Even if the source of the drug is unknown, the Robertson County Fair Association shall be entitled to disqualify the exhibitor and may forfeit all rights and privileges to exhibit livestock in the future at the Robertson County Fair.

- 31. To foster fair competition, to provide a level playing field and to protect the safety of food, the showing of unethically fitted livestock, livestock of any ineligible age for exhibition in the class entered, and/or animals being administered unapproved drugs is strictly prohibited. Additionally, any animal that has been administered a drug that is FDA approved for its species is subject to disqualification if that animal tests positive for that drug upon arrival at Robertson County Fair Grounds. All animals must remain free and clear of all drug and chemical residues while on show grounds. The use by non-veterinarians of animal drugs or other substances in any manner other than in accordance with the FDA-approved label is a violation of federal law.
  - a. Unethical Fitting: Unethical fitting means any attempt to alter the natural appearance, conformation, musculature or weight of an animal by any unnatural means. Animals showing any signs of being unethically fitted will be disqualified. Examples of unethical fitting include, but are not limited to the following:
    - i. application of any substance to any part of the animal's body, unless specifically allowed in the department rules of that species; injection, drenching or application of any substance per rectum is prohibited.
    - ii. use of injections
    - iii. draining of fluids
    - iv. bruising
    - v. feeding of material not conducive to the health of the animal, safety of food or marketability of its carcass
    - vi. surgical alterations
    - vii. artificially filling animals Example: airing injections
  - b. Therapeutic Practices: The practice or use of any therapeutic application including, but not limited to animal chiropractic services, acupuncture or electrical massage stimulation on show grounds is prohibited.
  - c. Unapproved Drug Use: The showing of any animal that has been administered during its life any quantity of any unapproved drug, chemical or medication is strictly prohibited. Such drugs include, but are not limited to, any diuretic, unapproved growth stimulant or other unapproved medication. Unapproved means not approved by the Food and Drug Administration (FDA) and/or the U.S. Department of Agriculture (USDA) for slaughter animals including animals that may be destined for human consumption.
  - d. Approved Drug Use: If an animal has been administered a drug that is FDA approved for its species and class, sufficient time must have passed so that the animal does not test positive for that drug upon arrival at Robertson County Fair Grounds. Animals must remain free and clear of all drug and chemical residues while on show grounds. Please note that elimination time (the time it takes for no drug residue to be found in the system) is generally longer than the labeled withdrawal time for most approved drugs.
  - e. Animal Inspection: As condition for participation in the Show, exhibitor must agree to submit any animal entered by the exhibitor for inspection. Exhibitor agrees to have such animal submitted to any tests requested by the Show. Exhibitor also agrees that the opinion reached by the Show or its officials as to whether such animal is unethically fitted shall be final and binding without recourse against the Show or any of its officers. Further, the Show specifically reserves the right to have tissue, blood, feathers and/or urine laboratory analysis made on any animal entered for competition. The conclusions reached by the laboratory shall be final and binding without recourse against the Show or any of its officers. An exhibitor of an animal that is found to be unethically fitted, and/or testing positive for any drug or medication or unapproved chemical may forfeit all rights and privileges to exhibit livestock in the future at the Show.
  - f. Unmanageable Animals: The Show may disqualify any animal deemed unmanageable.
  - g. Non-adherence to Rules: Any person found to be misrepresenting and/or not abiding by the Fair rules will be disqualified and denied the privilege of showing and/or selling in the Robertson County Fair.
  - h. Emergency Treatment: If an animal requires emergency treatment while on Show grounds, only a licensed veterinarian will be allowed to administer any drug, chemical or feed additive. An exhibitor may choose a licensed veterinarian other than the official Show veterinarian, but the official Show veterinarian MUST be notified in advance and he/she MUST be present. Animals which are administered treatments with a withdrawal or extended elimination time period will be disqualified from competition. Furthermore, The Official Show Veterinarian, in agreement with Show Management, reserve the right to treat any animal if, in the opinion of the Official Show Veterinarian, it is in the best interest of the animal's health and well-being to be treated. If the Official Show Veterinarian administers treatment to an animal, and therefore uses any medication that does not meet the appropriate withdrawal and or elimination time, will be determined ineligible for competition and/or sale.
  - i. Treatment Cost: All treatment costs are the responsibility of the exhibitor.

- 32. The RCFA expressly disclaims any express or implied warranties (including merchantability), whether the goods or services are provided by the RCFA or by others (such as drug testing). The RCFA does not provide security or guard services and is not responsible for the acts of third parties. Exhibitors and exhibitor's parents and/or guardians agree that the RCFA shall be entitled to disqualify any exhibitor whose animal tests positive for any drug, and even if the exhibitor and the exhibitor's parents and/or guardians are innocent of any wrong doing and had no role in the administration of the drug disclosed by the drug test. Even if the source of the drug is unknown, the RCFA shall be entitled to disqualify the exhibitor. Disqualification results in forfeiture of all prize money and auction proceeds.
- 33. Disqualifications/Condemnation of Animals: The RCFA reserves the right to condemn and/or disqualify any animal, either live or slaughtered, found in violation of the use of drugs, chemicals, or feed additives as described in General Rules #30 and #31 and the exhibitor will forfeit all auction sales and/or premium money if the animal is disqualified. If animal is disqualified for testing positive and/or the carcass condemned at slaughter, the class placing will not change. An exhibitor of an animal testing positive for any drug, medication, or unapproved chemical may forfeit all rights and privileges to exhibit livestock in future RCFA shows.
- 34. Dogs are not allowed on Show grounds because of safety and public health regulations. This rule will be strictly enforced and applies to all exhibitors and their employees as well as Show visitors. Exceptions are granted for service dogs that are individually trained to do work or perform tasks for a person with a disability. The task(s) performed by the dog must be directly related to the person's disability. The service animal must remain on a leash or otherwise be under the handler's control while on the Show grounds. To protect the health and well-being of all animals on Show grounds, the exhibitor may be asked to provide current health records, including vaccination records to the Show's veterinarian. Exceptions are also granted for dogs under contract with the Robertson County Fair for demonstration, competition and entertainment purposes. Dogs entered as a part of the youth pet show on Sunday morning will be allowed in the barn only on Sunday morning and must remain on a leash when not in the pet show ring.
- 35. Any individual and /or group displaying unsportsmanlike or unethical behavior will be subject to disciplinary action by the RCFA which could include any and/or all of the following, dependent on the severity of the infraction determined by show officials: Verbal warning, written warning, disqualification from the show and sale, removal from the grounds for the day, removal from the grounds and banning for the remainder of the fair, banning from the fair for life or community service assigned by the show officials.
- 36. The Show may appoint sifting committees to determine the eligibility of animals to compete prior to judging. Animals must be unblanketed and ready for inspection by the sifting committee at the announced time of sifting. The sifting committee will eliminate any animal which, in its judgment, is not qualified to compete. At the committee's recommendation, the Show may require these animals to be removed from the grounds. The sifting committee's decisions are final and protests will not be considered by the Show.
- 37. All protests must be in writing and be accompanied by a \$300 deposit which will not be returned if protest is not sustained by Show Management. Protest must state plainly the cause of complaint or appeal and must be delivered to the Show Management immediately after the occasion that prompted the protest. Protests will be accepted prior to, during and within 2 hours immediately following the occasion that prompted the protest. Protests concerning ages of animals must be filed with the Show Management prior to the day on which the animal(s) is/ are to be judged. Judging procedures will not be interrupted for protest investigation. Depending on the basis of the protest, a decision may be withheld until a complete investigation has been conducted.
- 38. Any exhibitor entering the Robertson County Fair gives permission for any and all photographs/videos taken by official RCFA photographers to be the property of the RCFA. Any of these may be used in advertisements and/or posts for the RCFA. The RCFA reserves the right to sell photos and/or videos.

- 1. Read General Rules.
- 2. Exhibitors must own animal by October 25, 2023. Steers and exhibitors will be checked in on this date and steers will be nose printed, tattooed, and ear tagged at the Franklin ISD Agricultural Facility. This check-in is required and does not count as a clinic for the RCFA steer show. A \$5.00 tagging and tattoo fee per head will be assessed at tag-in. Animals not present at the check-in may be allowed to enter at the discretion of the Steer Committee, with approval by the Superintendents prior to the check-in date. Only major/county show validation tags and the RCFA tattoo (county tagged steers only) are allowed in a steer's ears.
- 3. Every exhibitor must meet the clinic participation rule as outlined in Rule #24 of the General Rules.
- 4. Entry fee for the steer show is \$25.00 per head and is due March 1, 2024.
- 5. Minimum weight for steers shall be 1,000 pounds with no upper weight limit.
- 6. The calves classified in the American-cross breed must exhibit enough breed characteristics to indicate they could have been sired by or out of an animal registered in an American breed association.
- 7. A committee of three qualified individuals with prior cattle experience will be selected to classify all steers. This committee's decisions will be final.
- 8. Beginning at 6:30 pm and until 7:30 pm on Thursday, March 21, 2024, exhibitors will turn in their weight cards and present their steers for classification. All steers will be classified as American-cross or European.
- 9. All market steers must be slick shorn with no more than one-fourth (1/4) inch length of hair, except for tail switch, when steers are checked in for the RCFA steer show.
- 10. If there are 35 or less there will be 5 classes of American Cross and/or European breeds.

#### 11. Re-weigh:

- a. All sale animals automatically qualifying for the sale will be reweighed. A maximum 5% increase or decrease in the official weight as turned in by the exhibitor for each steer will be allowed. Any steer weighing greater than or less than 5% of the official weight will be disqualified. If a steer is disqualified based on this re-weigh rule, the next placing steer will move up and will be subject to this re-weigh rule.
- b. Exhibitors must re-weigh immediately after leaving the ring following class placement. Exhibitor will be disqualified if he/she goes to their stall prior to official weigh back. Steers will be weighed with Superintendent and Scale Master present. If steer does not meet weigh back criteria the steer will be re-weighed one additional time immediately after first weight to verify steers actual weight. Steers placing below sale steers must wait at scales until automatic sale slots are certified.
- 12. Only the Judge, Ring Stewards, Exhibitors and their steers will be allowed in the show ring during the judging of the classes.
- 13. Uncontrollable steers will be subject to disqualification by the judge.
- 14. Twenty steers or calves may be sold.
- 15. Any exception to these rules must receive approval from the Steer Superintendents.
- 16. Showmanship will be held at the conclusion of the steer show and will be conducted in accordance with Rule #22 of the General Rules.
- 17. No load out of cattle until the completion of the Market Steer Champion Drive.
- 18. At a minimum, the Grand Champion, Reserve Champion and one random will be tested for drug residue as outlined in Rule #29 of the General Rules.

- 1. Read General Rules.
- 2. Exhibitors in this show must be residents of Robertson County and 4-H and FFA members of clubs in Robertson County. Exhibitors must be certified by a Robertson County Extension Service Agent or an Agricultural Science Teacher. Exhibitors must also:
  - a. Meet all eligibility requirements at time of show as set forth by the Texas Education Agency and the exhibitor's school district.
  - b. Forfeit the right to exhibit and sell their projects during the heifer show and sale and all required fees for failing to meet eligibility requirements.
- 3. All Junior Commercial Heifer entries will be tagged and tattooed with RCFA tattoo at the Robertson County Veterinary Clinic in New Baden on Saturday, October 28, 2023 from 8:00 am to 11:00 am. A tagging and tattoo fee of \$10.00 per head will be assessed at tag-in. At tag-in all heifers will be vaccinated/revaccinated for Lepto, Vibrio, IBR complex and 8-way Blackleg at exhibitor's expense.
- 4. All heifers must be Brucellosis calf hood vaccinated on or before the tag-in date of Saturday, October 28, 2023. All heifers must have a metal calf hood vaccination tag and/or a vaccination tattoo in their ear.
- 5. Heifer entries must be open and no more than 13 months old and no less than 8 months of age as certified by the exhibitor at tag-in on Saturday, October 28, 2023 and not more than 18 months but not less than 13 months on Saturday, March 23, 2024.
- 6. All heifers must be naturally polled or dehorned. Heifers must be dehorned before the tag-in date.
- 7. A \$25.00 entry fee per pen of heifers is due on March 1, 2024.
- 8. Heifers will be checked in at the Calvert Sale Barn on Friday, March 22, 2024 from 5:00 pm to 7:00 pm. Two heifers shall constitute a pen of heifers. An exhibitor may enter only one pen of two heifers from the heifers the exhibitor originally tagged-in on Saturday, October 28, 2023.

- 9. All heifers must be palpated and toothed by a licensed veterinarian between Saturday, February 24, 2024 and Thursday, March 14, 2024. Any heifer found to be pregnant or have an unsound reproductive tract or that has lost a baby tooth and a permanent incisor has broken the skin, will be deemed ineligible to show. Two copies of a Certified State Health Certificate provided by a licensed veterinarian guaranteeing the heifers to be open, have a sound reproductive tract and are of the proper age must be turned in at the time of check in. An additional copy of this document must be included in the exhibitor's Record Book that is due on Thursday, March 14, 2024. Hilite each Exhibitor's name and the 2 heifers' ear-tag numbers that the exhibitor is showing. Health certificates may include multiple immediate family members participating in the Commercial Heifer Show but each exhibitor must put a copy in their record book and 2 copies must accompany each pen of heifers at check-in. For example, a family of 2 exhibitors must have a total of 6 copies: One copy for each of the 2 record books (2) and the 2 copies for each of the 2 pens of heifers (4) at check-in.
- 10. In order for an Exhibitor to participate in the RCFA Commercial Heifer Show, they must, (1) turn in Record Book on the specified date and time; (2) go through the Interview process on the date and time specified; and (3) check in a pen of two heifers, that meet the requirements, the day of check-in at the Calvert Sale Barn located in Calvert, TX. If any of these three requirements are not met, the participant will be deemed ineligible to show or sell.
- 11. Heifers will be verified at arrival at the Calvert Sale Barn on Friday, March 22, 2024 by an independent 3-member committee. They will be classified according to breed characteristics and will then show in one of three breed divisions as described below. This independent classifying committee will be designated by the heifer committee to determine breeds of each heifer. Based on the decisions of the classifiers, heifers will be assigned to one of the following breed divisions:
  - a. Braford Influence Cattle that exhibit Braford characteristics.
  - b. Other Brahman Influence All other cattle which exhibit Brahman characteristics.
  - c. All Other Breeds Cattle not included in the above divisions (ex. Hereford, Angus, Exotic Crosses, etc.) Furthermore, all heifers will be classified at check-in for their eligibility to compete. If any heifers are deemed ineligible to compete, they will not be eligible to be shown and sold. Issues making a heifer unmarketable include but are not limited to, pregnant or appearing to be pregnant, lameness including broken limbs, broken noses or any other deficiencies as deemed ineligible to compete by the independent 3 member classifying committee. If a heifer is deemed ineligible the exhibitor has until the end of the check in to bring the replacement heifer to the fairgrounds. If the exhibitor does not have a replacement heifer, they will be unable to show and sell the remaining heifer.
- 12. Exhibitors are required to submit a record book for competition using the RCFA Youth Commercial Heifer Show and Sale record book guidelines. Exhibitors are also required to prepare a sales flyer about their Commercial heifers. Record books must be turned in by the date and time specified. Late entries of record books will not be accepted. If an exhibitor does not turn in a record book on time, they will not be allowed to interview or participate in the RCFA Commercial Heifer Show. Record books will be turned in at "TBD" on Thursday, March 14, 2024, from 4-7 pm.
- 13. Every exhibitor must meet the clinic participation rule as outlined in Rule #24 of the General Rules.
- 14. The record book/interview/presentations portion of the show will have three age divisions. They will be judged and scored as follows:

School Grade	Age Division	Scoring
$3^{\text{rd}}$ , $4^{\text{th}}$ or $5^{\text{th}}$	Juniors	30% Record Book, 70% Interview
$6^{th}$ , $7^{th}$ or $8^{th}$	Intermediates	30% Record Book, 70% Interview / Poster Board Interview
$9^{th}$ , $10^{th}$ , $11^{th}$ or $12^{th}$	Seniors	10% Resume / Sales Flyer, 20 % Record Book 70% Oral Presentation

- 15. The pen of heifers will be judged on Saturday, March 23, 2024 beginning at 8:00 am. Placing will be determined based on quality and uniformity of the heifers. The heifer judging and the record book/interview/presentation portion of the heifer show will be separate, and therefore, separate awards given for winners in the heifer judging portion and the record book/interview/presentation portion of the commercial heifer show.
- 16. Any hay fed to heifers during the show must be fed in a hay net. If contestant does not have a hay net, hay will not be allowed to be fed.
- 17. The RCFA will present awards to the Grand Champion and Reserve Champion pens and other placing pens and to the Grand Champion and Reserve Champion Junior, Intermediate, and Senior record book/interview/presentation winners and others placing in this portion of the commercial heifer show.
- 18. Since this is a terminal show, all heifers must sell in the Commercial Heifer sale on Saturday, March 23, 2024. Heifers will be sold as a pen with the number of heifer's times the money bid being the amount received. A 10% sales commission will be deducted from each sales lot. Additionally, the amount the exhibitor receives will also be subject to the Beef Check-off fee will be deducted from the sale of each heifer to comply with the National and/or State Beef Check-off Program.
- 19. All heifers will be released by the commercial heifer committee following the conclusion of the sale and exhibitors are responsible to determine the disposition of their heifers prior to leaving the commercial heifer sale.
- 20. The Robertson County Youth Commercial Heifer Show and Sale Committee members act as agents only for the exhibitors. All guarantees are between buyers and the sellers.
- 21. All heifers entered in this program and sold become the property of the buyer and shall remain sold.
- 22. There will be no harassment of the veterinarians, classifiers, or judges prior to, during, or after the show.
- 23. This program is designed to be educational and beneficial to the youth of Robertson County.
- 24. In the event an exhibitor's heifer(s) loses an official RCFA Commercial Heifer tag, it is the responsibility of the exhibitor to notify the Commercial Heifer Committee so that the heifer(s) can be re-tagged.
- 25. Heifers must be in the possession of the exhibitor on or before the tag-in date and remain in the exhibitor's possession throughout the feed period.
- 26. Exhibitors participating in the commercial heifer show may also compete in the market animal show and are eligible to sell entries in both the commercial heifer sale and the premium auction (i.e. market steers, lambs, goats, hogs, rabbits, poultry, or baked goods).
- 27. Each exhibitor is responsible and liable for the breeding, age, health, and all fiscal warranties expressed or implied on the cattle sold. Exhibitor agrees to hold the RCFA and the auctioneer(s), RCFA Commercial heifer Committee or any other representative of the cattle hold harmless if legal action ever occurs.

- 1. Read General Rules.
- 2. Lambs must be owned by October 31, 2023 and by this date all lambs (Market and Breeding) to be shown in the 2024 RCFA market lamb show will be ear tagged, ear tattooed and nose printed. Animals not tagged in on or before October 31, 2023 will be ineligible to show in the Robertson County Fair. There will be two (2) tag in dates, TBA, which will accommodate major show tag-in as well as Robertson County Fair tag-in. All lambs will be validated with major tags for the RCFA Fair, all exhibitors will need to let the Robertson County Extension office know how many tags they will need. Cost is \$20 for each tag. There will be no County Only tags used. This check in is required.
- 3. Every exhibitor must meet the clinic participation rule as outlined in Rule #24 of the General Rules.
- 4. If an exhibitor's lamb loses an ear tag, the exhibitor or parent must contact the lamb superintendent. The lamb will be re-tagged and re-nose printed if needed.
- 5. Wether or ewe lambs will be eligible to be shown in the market lamb show.
- 6. Animals must weigh at least 100 lbs. on the day of check-in to be eligible to show. There is no upper limit.
- 7. Check-in for the lamb show will be held on Friday, March 22, 2024. Exhibitors will check in and then weigh their own animals and turn in weight cards to the market lamb superintendent by 12:00 pm Friday, March 22, 2024. All lambs may be nose printed at check-in and prints compared to those taken at the tag in prior to October 31, 2023. The lamb committee will divide lambs into five (5) classes. There must be five (5) lambs to constitute a class. Lamb classes will be broken by weight only and will not be broken into individual breeds.
- 8. All lambs must be slick shorn and may not have more than 2 weeks growth of wool.
- 9. Pens will be selected on setup day by those who help, all other exhibitors will have their pens assigned prior to the show. All pen assignments will be posted at check in for all exhibitors to know their pen.
- 10. All first-place lambs will compete for Grand Champion. Once the Grand Champion is selected, all remaining first place lambs and the second-place lamb from the class where the Grand Champion came out will be eligible for selection as Reserve Champion. Belt buckles will be awarded to the Grand and Reserve Champion Lambs. Ribbons will be awarded to every exhibitor.
- 11. Showmanship age divisions will be followed as outlined in Rule # 22 of the General Rules. Prizes will be presented for Showmanship. In addition, a novice showmanship division will be judged. To qualify for Novice, it must be the exhibitor's first year to show either a lamb or a goat. Exhibitors (no matter their age) can choose to participate in either (but not both) the novice division or their appropriate age division for showmanship. - 14. All market lambs will remain on the fairgrounds from time of check-in until released by lamb supt.
- 15. Drenching of lambs is allowed on the fairgrounds.
- 16. All lamb exhibitors making the premium auction are required to assist with the peewee lamb/goat show. Those that fail to assist with the peewee show will be assessed a \$100.00 penalty to be deducted from their sales check unless they have been excused by the lamb superintendent.

Animals not tagged in on or before October 31, 2023 will be ineligible to show in the Robertson County Fair. There will be two (2) tag in dates, TBA, which will accommodate major show tag-in as well as Robertson County Fair tag-in. All goats will be validated with major tags for the RCFA Fair, all exhibitors will need to let the Robertson County Extension office know how many tags they will need. Cost is \$20 for each tag. There will be no County Only tags used. This check in is required.
- 3. Every exhibitor must meet the clinic participation rule as outlined in Rule #24 of the General Rules.
- 4. If an exhibitor's goat loses an ear tag, the exhibitor or parent must contact the goat superintendent. The goat will be re-tagged.
- 5. Wether or doe kids will be eligible to be shown in the market goat show. Additionally, any breed or crosses of meat type goats will be eligible to show.
- 6. Animals must weigh at least 60 lbs. at check-in to be eligible to show. There is no upper weight limit.
- 7. Check-in for the goat show will be held on Friday, March 22, 2024. Exhibitors will check in and then weigh their own animals and turn in weight cards to the market goat superintendent by 12:00 pm Friday, March 22, 2024. The goat committee will divide goats into four (4) classes. There must be five (5) goats to constitute a class. Goat classes will be broken by weight only, not broken into individual breeds.
- 8. Market goats must be slick shorn with 3/8 inch of hair or less over the entire body above the knee and hocks (with the exception of the tail) at the time of the show.
- 9. Pens will be selected on setup day by those who help, all other exhibitors will have their pens assigned prior to the show. All pen assignments will be posted at check in for all exhibitors to know their pen.
- 10. All first-place goats will compete for Grand Champion. Once the Grand Champion is selected, all remaining first place goats and the second-place goat from the class where the Grand Champion came out will be eligible for selection as Reserve Champion. Belt buckles will be awarded to the Grand and Reserve Champion goats. Ribbons will be awarded to every exhibitor.

If an Exhibitor has a bird that has been sifted, the Exhibitor may use an alternate bird. Turkeys losing their wing bands for any reason will not be eligible to show.   - a. At the weigh-in, one of the rabbits in the pen of three does not meet the weight requirements, OR
  - b. If after weigh-in and sifting, a rabbit becomes sick or injured. The substitute rabbit must pass the same weigh-in and sift requirements.
- 4. The exhibitor must own the breeding doe on or before December 1, 2023. The Rabbit Committee reserves the right to inspect all does and bunnies on the exhibitor's premise to verify doe ownership. Only Californian and New Zealand breeds will be allowed to enter the market rabbit show.
- 5. Exhibitors must inform the Rabbit Committee prior to the December 1, 2023 deadline verifying the exhibitor's intention to show rabbits in the 2024 Robertson County Fair and the location of their does for inspection and verification by the Rabbit Committee.
- 6. All entries must have a special RCFA-approved tattoo in the right ear. Tattoos will be applied by the Rabbit Committee on the rabbit validation day as set by the Rabbit Committee. A tattooing fee of \$10.00 per family will be assessed during this validation day.
- 7. Check-in will be on Friday, March 22, 2024 from 3:00 pm to 5:00 pm. Pens will be furnished for the rabbits. Rabbits will be checked, weighed, and sifted at this time. The exhibitor will be responsible for feeding and watering their own rabbits during the show. The Show will begin at 8:00 am on Saturday, March 23, 2024. The breeding show and fryer rabbit will follow the market show and these two shows shall be a carrying cage only show.

- 10. All food items will be sampled by the judges and will be judged on taste, texture, appearance, presentation, recipe, and Food Division Questionnaire.
- 11. All food items must be made from scratch. The use of Jello mix, canned sodas and canned fruit are acceptable but should not be the main ingredient of the entry. ITEMS NOT ALLOWED but not limited to cake mixes, Cool Whip, pre-made crusts, or marshmallow crème. Store bought candies and cookies may be used only as a garnish. Garnish: *verb*; to decorate or embellish (something, especially food).
- 12. No food item requiring refrigeration will be accepted as referenced by The Texas Department of State Health Services: "Bakery goods which require any type of refrigeration such as cream, custard or meringue pies and cakes or pastries with cream cheese icings or fillings". NOTE: 6 Tablespoons or less of milk or heavy cream is acceptable in the icing recipe; anything more will be rejected or disqualified unless the recipe is a cooked icing.
- 13. All entries must maintain their taste, texture and appearance at room temperature for at least 8 hours.

- 14. Exhibitors of canned goods must:
  - a. Properly seal jars using a water bath or pressure canner.
  - b. Include the canning process on their recipe.
  - c. Be prepared to submit 64 ounces of canned goods in any combination of jar sizes should they make the Silent Auction.
- 15. Classification of food entries not clearly defined by the exhibitor will be left to the discretion of the food division superintendent(s).
- 16. All first-time food exhibitors are required to attend at least one clinic hosted by the food division superintendent(s) or provide proof of attending Health Card Certification. All others are also encouraged to attend a clinic or provide proof of Health Card Certification.
- 17. There will be a showmanship competition for the Junior, Intermediate, and Senior divisions with awards given. The interview process will take place on Saturday, March 23rd after the judging of the food (times to be determined and announced via email).
  - a. The exhibitor must indicate their desire to participate in the showmanship competition during the online entry process and must indicate which entry they would like to be interviewed.
  - b. The exhibitor will be interviewed and scored based on the following criteria: appearance, attitude, knowledge of his/her entry, and communication skills.
- 18. No Pee Wee food entries will be eligible for the silent auction.
- 19. Blue-ribbon Junior and Senior winners within the Food Division categories, including Grand and Reserve Champion will be eligible for the silent auction, with the winning bids announced during the premium auction set for Monday, March 25, 2024 beginning at 6:30 pm. Should a blue-ribbon Junior or Senior winner sell an animal project, an alternate from that winning category will be moved up to sell.
- 20. Should an exhibitor make the sale with their Food Division item as well as their animal and decide to sell their animal, the exhibitor WILL NOT be allowed to enter the winning recipe for the remainder of their showing career.

- 3. In order to receive a cash prize, each winner and a parent/guardian (if the winner is an elementary student) will be required to commit to supervising artwork in the Multi-use building for a one (1) hour period during weekend viewing times. Winners are expected to write a thank you during this time and take a picture with their winning project.
- 4. Arts, Crafts, and Sculpture age divisions will be divided by grade: K-12. Adult Art, Crafts, and Sculpture will be judged separately from the students.
- 5. Judges selected to judge the Arts, Crafts, and Sculpture Departments shall be professional artisans and photographers and/or professional art or photography educators. No one will be allowed to watch the judging.

  - f. Professional Anyone who teaches photography, sells photos or their services as a photographer.

- 7. Entry fees are \$5.00 per entry due on March 1, 2024. Individuals may submit as many entries per category as they choose.
- 8. Photographs must be mounted flush to the edge of a rigid, self-adhesive 8-inch X 10-inch foam board. Each entry must be submitted in a separate Ziploc bag. Please put your name, grade, and category on back of picture. Photos not mounted according to rules will not be eligible for entry.
- 9. All entries must be received in the Multi-use building on Monday, March 18, 2024 between 4:00 and 7:00 pm. No late entries will be allowed after check-in.
- 10. Entries will be judged by professional photographers and no one will be allowed to view the judging.
- 11. Entries are to be removed from the multi-use building by 3:00 pm Sunday, March 24, 2024.

- 12. At the discretion of the judges, First, Second, and Third level ribbons will be awarded to each piece of Youth photography submitted.
- 13. Special Category Awards will be given, at the judge's discretion, to outstanding entries.
- 14. The Adult Photography and Professional Photography divisions will only award a "Best of Show" for each division.
- 15. Rosettes and cash prizes (if funds are available) will be awarded to the Division, Grand and Reserve Champions, and the Best of Show winners.
- 16. All cash winners and a parent/guardian (if the winner is a child) will be required to supervise a one hour period during viewing hours. Failure to do so will result in forfeiting your cash prize. It is your responsibility to check to see if you have won a prize and sign up to supervise.
- 17. RCFA has the right to remove any show entries viewed as inappropriate.

# **Greased Pig Scramble**

## Superintendents: Terri & Ervin Homann

- 1. The Robertson County Fair Association, Inc. will not be responsible for any accidents connected with the pig scramble.
- 2. The Interscholastic League Executive Committee, in cooperation with the State Board of Vocational Education has formulated a plan permitting Greased Pig Scrambles while still protecting a contestant's amateur status. This is done by placing this process under a school's and/or a County 4-H Club supervision and prohibiting participants from receiving anything of cash value from the athletic portion of the school's program.
- 3. Divisions are determined by age or grade of exhibitor as of January 1, 2024.
  - a.  $Junior 3^{rd}$  grade through 13 years of age
  - b. Senior 14 years of age through 18 years of age with one year of show eligibility remaining
- 4. Must be a current member of FFA, 4-H or FCCLA.
- 5. Contestants must sign up on the Market Entry Form and return form no later than March 1, 2024. NO LATE ENTRIES ACCEPTED. A \$5.00 non-refundable entry fee will be charged for each person entered in the scramble. Any contestant that has a known conflict on either of the scramble days (i.e. showing at the same time, athletics, school activity, etc.) shall attach a note explaining the conflict to the entry form for review by the Pig Scramble Committee. The committee shall reserve the right to accept or reject any and all such requests.
- 6. The number of heats will be determined by the Pig Scramble Committee.
- 7. Each contestant will attempt to catch one of the pigs and then pull or carry the pig to the designated pen without assistance. Referees will declare winners and order of finish.
- 8. All pigs must be carried or pulled across the designated pen threshold.
- 9. If two or more contestants catch the same pig, they both will be required to release the pig by order of a referee.
- 10. Poor sportsmanship will disqualify any contestant automatically and undue roughness will not be tolerated by the referees. Any abuse of the pigs will result in immediate disqualification and forfeiture of Scramble Purchase Certificate.
- 11. Scrambles will be refereed by a group of not less than four referees and all decisions of referees shall be final.
- 12. A Scramble Purchase Certificate will be issued to the top three finishers in each scramble heat. The order in which contestants successfully get their pig into the designated pen will determine placings.
- 13. A Scramble Purchase Certificate must be used for the purchase of an animal project or supplies to be used in the exhibition of their animal, foods or creative arts project for the 2025 Robertson County Fair. The certificate must be redeemed before March 1, 2025 or it will be voided.

- 14. The entire program, including the selection of the kind of animal project, the care of the animal project, and management of the animal project will be under the supervision of the County Extension Agent or Agricultural Science Teacher.
- 15. The Scramble Purchase Certificate must be signed by the County Extension Agent or Agricultural Science Teacher verifying the Certificate was properly used before payment will be made.
- 16. Thank you notes will be required. Winning scramblers are to prepare Thank you notes for the sponsor(s) of their purchase certificate. Thank you notes must contain the correct donor's name and address and must be placed in an unsealed, stamped envelope addressed to the donor. These Thank you notes and envelopes are required to be mailed to Terri Homann, Pig Scramble Superintendent, for approval and verification to the address provided by Mrs. Homann. All Thank you notes must be received by Mrs. Homann on or before April 30, 2024. Winning scramblers who fail to comply with this Thank you note rule by the April 30, 2024 deadline shall forfeit their scramble purchase certificate.
